Only artists, makers, crafters who handcraft their items will be accepted as exhibitors in the Arts and Crafts Market.

- 1. All paperwork must be filled out completely, payment received and written approval provided to obtain a vendor location # .
- 2. There is no exclusive vendor product policy that will be enforced. The following products will not be allowed:
  - Balloons, toy weapons, marshallow shooters or noise makers of a novelty nature. Items that constitute the possibility of a public nuisance.
  - The Arts & Crafts chairman reserves the right to prohibit any items at any time and remove vendor if necessary.
- 3. All vendors are responsible for keeping their assigned location clean and safe.
- 4. There is no parking in the festival grounds. No vehicle access is allowed in the park one hour before the festival opens through closing. For the safety of our patrons, there can be no exceptions to this rule.
- 5. Vendor locations are assigned by the A & C Chairman. We will try to accommodate special requests but requests are not guaranteed.
- 6. All displays must be tasteful and appropriate for a family environment and all age groups.
- 7. You will need to break down each day. We will not provide overnight security.
- 8. The Arts & Crafts Chairman reserves the right to terminate your agreement at any time, without refund, during the festival for non-compliance to these rules.
- 9. There is no refund policy.
